The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I: NAME**

The name of the corporation is **South Florida Telcom Forum, Inc.**

**ARTICLE II: PRINCIPAL OFFICE**

The principal place of business and mailing address of the corporation is 2781 Ocean Club Blvd., Suite 304, Hollywood, FL 33019.

**ARTICLE III: PURPOSE**

The specific nature of business is to provide telecommunications information clearinghouse and professional forum.

**ARTICLE IV: QUALIFICATION**

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

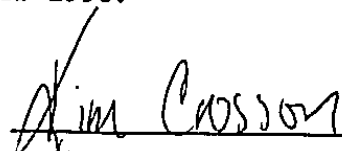
### **ARTICLE X: AMENDMENTS**
