ARTICLES OF INCORPORATION OF LIFEWORK YOGA STUDIOS, INC (A Corporation Not for Profit)

We, the undersigned, with other persons being desirous of forming a corporation exclusively for professional and educational purposes, under the provisions of Chapter 617 of the Florida Statues, do agree to the following:

ARTICLE I. NAME

The name of the corporation shall be: LIFEWORK YOGA STUDIOS, INC

ARTICLE II. PURPOSES

1. This corporation is organized to foster the development and improvement of the health and health education through the teaching of the general public, the training of teachers and the general community.

2. The purposes for which this corporation is organized are within the scope of Section 501(c)(3) of the Internal Revenue Code of 1954, or the corresponding provision of any future United States Internal Revenue law, as a non-profit organization.

ARTICLE III. MEMBERSHIP

1. The qualifications of members and the manner of their admission shall be as provided in the By-Laws.

2. All members of the unincorporated association known as Lifework Yoga Studios, Inc. on the date these Articles become effective shall be members of this Corporation subject to the membership provisions of the By-Laws.

This Corporation shall exist perpetually.

ARTICLE VIII. AMENDMENTS AND BY-LAWS

These Articles of Incorporation and the By-Laws of this Corporation may be made, altered, amended, or rescinded by the at any regular or special business meeting provided that a notice stating the proposed change and the time and place of the meeting where the same will be considered has been given at least seven (7) days in advance to each member entitled to vote.

ARTICLE IX. NON-PROFIT

The Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. No part of the income of the corporation shall be paid or inure to the benefit of any person, but the corporation shall be authorized to pay reasonable compensation for services rendered and may confer benefits upon its members in conformity with its purposes.

ARTICLE X. TAX EXEMPT STATUS

Not withstanding any other provision of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by a corporat. In exempt from Federal Income tax under Section 501 (c) (3) of the Internal Revenue Code (or the corresponding provisions of any future U.S. Internal Revenue Law) or by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code (or the corresponding provision of any future U.S. Internal Revenue Law.)

ARTICLE XI DISTRIBUTION OF ASSETS

No person, firm or corporation shall ever receive any dividends or profits form the undertakings of this corporation and upon dissolution of this organization all of its assets remaining after payment of all costs and expenses of such dissolution shall be distributed to other organizations which have qualified for exemption under Section 501 (c) (3) of the Internal Revenue Code (or the corresponding provision of any future U.S. Internal Revenue Law), or to the Federal government or to a State or local government, for a public purpose.
