ARTICLES OF INCORPORATION OF WILLING WORKERS FOR COMMUNITY IMPROVEMENT, INC.

The undersigned, acting as incorporators of a Corporation under the Florida Not For Profit Corporation Act, Chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I - MAME

The name of the corporation shall be WILLING WORKERS FOR COMMUNITY IMPROVEMENT, INC.

ARTICLE II - DURATION

The corporation shall have perpetual duration.

ARTICLE III - INITIAL REGISTERED AGENT AND ADDRESS

The principal place of business and the mailing address of this corporation shall be 2304 Avenue I, Fort Pierce, Florida 34950, and the name of the initial registered agent at such address is Oliver Cox.

ARTICLE IV - PURPOSE

The purposes for which the corporation is organized are:

- 1. To establish a broad-based community group to work in partnership with the City of Fort Pierce and the community at large in a sincere attempt to improve the city and restore hope to the community.
- 2. To work with residents, civic groups, clubs, government and other organizations to clean up, fix up and beautify neighborhoods within the City of Fort Pierce.
- To develop and implement strategies for economic development and revitalization.

- 4. To educate property owners, tenants, business owners and concerned citizens about their role in revitalization efforts.
- 5. To solicit donations, apply for grants, enlist investors and obtain loans to carry out community projects.
- 6. To engage in other activities and functions as are proper and in furtherance of the goals and purposes of the corporation.
- 7. To organize and operate the corporation exclusively for charitable purposes under Section 501(c)(3) of the Internal Revenue Service Code of 1954 (or corresponding provision of any future United States Internal Revenue Law); and therefore, it shall be subject to the following provisions:
 - a. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, directors, officers or other private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered.
 - b. No part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
 - c. Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on, (1) by a corporation

exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Law or, (2) by a corporation, contributions to which are deductible under Section 180(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provisions of any future law).

d. Upon dissolution of the corporation and the discontinuance of its functions, the assets shall be disposed of as required by Florida Statutes Annotated, Section 617.05, and all the assets remaining after payment of outstanding liability shall be given to one or more organizations exempt under Internal Revenue Code 1954, Section 501/c)(3).

ARTICLE V - BOARD OF DIRECTORS

The Corporation shall have no stockholders. It shall have such members and classes of members as may be designated in the By-Laws. Affairs of the corporation shall be managed by a Board of Directors consisting of not less than five (5) members and not more than eleven (11) members, herein called Directors, who shall be elected by the members of the corporation in the manner and serve for the term as prescribed in the By-Laws. The actual number of Directors to comprise the Board of Directors shall be seven (7) at the outset, and thereafter it shall be such number within the limits set hereby as the By-Laws shall state, provided that the By-Laws shall have been adopted changing such number. The Board of Directors may delegate specific duties and responsibilities to its corporate officers as prescribed in the By-Laws.
