ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I NAME

The name of the corporation shall be NATIONAL ASSOCIATION FOR DIVORCE REFORM, INC.

ARTICLE II PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS

The principal place of business and the mailing address of this corporation shall be: 7451 West Oakland Park Boulevard, Fort Lauderdale, Florida 33319.

ARTICLE III PURPOSE

The specific purpose for which the corporation is organized are: To educate the public about the benefits of peaceful resolution of family matters, to explore and advocate alternatives to divorce in the adversarial process, to urge parties facing divorce to mediate the issues rather than to litigate them, to assist people in mediating family matters, to establish standards for pre-litigation mediation and for mediators who engage in that process and to explore legislative changes that will improve the divorce process and to serve such other lawful acts as are deemed appropriate by the corporation.

ARTICLE IV MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed shall be as provided for in the by-laws.

ARTICLE V LIMITATION OF CORPORATION POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.

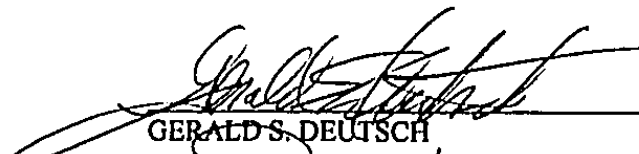

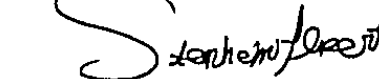
