The undersigned, acting as sole incorporator under the Florida Not For Profit Corporation Act, adopts the following articles of incorporation for String Parents Association, Inc.

1. The name of the corporation is STRING PARENTS ASSOCIATION, INC.
2. The corporation's duration shall be perpetual.
3. The purpose of the corporation is to foster the development of the musical talent of string students attending The Palm Beach County School of the Arts by conducting string classes, providing for enrichment activities, and providing for the purchase and repair of musical instruments. The corporation is not for profit and no part of the corporation's net earnings may inure to the benefit of, or be distributable to its members, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes of this corporation.
4. The qualifications for members and the manner of their admission shall be regulated by the bylaws.
5. The corporation's principal office is located at 3701 North Shore Drive, West Palm Beach, Florida 33407.
6. The name of the corporation's initial registered agent is Sandra T. Price and the initial registered office address is 9418 SE Sharon Street, Hobe Sound, Florida 33455.


8. The method of electing directors shall be as stated in the by-laws.

Notwithstanding any other provision of these Articles, neither this corporation nor any of its directors, officers, employees, or representatives shall carry on any activities or take any actions on behalf of the corporation which are not permitted to be carried on by an organization exempt from federal income tax under S 501 © (3) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States internal revenue law, or by any organization, contributions to which are deductible under S 170 © (2) of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States internal revenue law.

On the dissolution of this corporation the Board of Directors shall dispose of all the assets of this corporation exclusively for the purposes of the this corporation in the manner or to the organization or organizations that are organized and operated exclusively for charitable, educational, religious or scientific purposes and that shall at the time qualify as exempt organizations under S 501 © (3) of the Internal Revenue code of 1986, as amended, or the corresponding provision of any future United States internal revenue law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes or to the organizations that the court determines are organized and operated exclusively for charitable, educational, religious or scientific purposes. No private individual shall share in the distribution of any corporate assets upon dissolution of the corporation.

This corporation shall not apply accumulation of income in any manner which may subject it to denial of exemption as provided under S 504 of the Internal Revenue Code of 1986, as amended, or the corresponding provision of any future United States internal revenue law.


