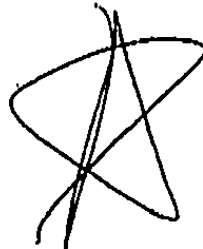

and adopt the following Articles of Incorporation:

ARTICLE 1

NAME

The name of the Corporation is: Consejo de Periodistas

ARTICLE 2

NOT FOR PROFIT

The Corporation is a nonprofit corporation under the laws of  
the State of Florida. The Corporation is not formed for pecuniary  
profit. No part of the income or assets of the Corporation is  
distributable to or for the benefit of its Members,  
Trustees or Officers, except to the extent permissible under law.

ARTICLE 3

DURATION

The duration (term) of the Corporation is perpetual.

ARTICLE 4

PURPOSES

The Corporation is organized, and shall be operated  
exclusively for, the following purposes:

To do any and all charitable activity permitted under the  
State of Florida in accordance with any and all applicable Internal  
Revenue Regulations that permit the raising of revenue by tax

To exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations including without limiting the generality of the foregoing, to acquire by bequest, devise, gift, purchase, lease or otherwise any property of any sort or nature without limitation as to its amount or value, and to hold, invest, reinvest, manage, use, apply, employ, sell, expend, disburse, lease, mortgage, convey, option, donate or otherwise dispose of such property, for any of the purposes set forth herein.

To do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

#### ARTICLE 5

##### LIMITATION
