Articles of Incorporation of the undersigned, desiring to form a non-profit corporation under the Non-profit Corporation Law of chapter 617, Florida Statutes, do hereby certify:

**ARTICLE 1. NAME**

The name of the Corporation is: Christ Jesus Redeems Forum, Inc.

**ARTICLE 2. DURATION**

The Duration of the Corporation is Perpetual.

**ARTICLE 3. PLACE OF BUSINESS**

The principal office of the Corporation is 975 N.W. 132nd Street, North Miami, Florida.  
The mailing address of the Corporation is 975 N.W. 132nd Street, North Miami, Florida 33168.

**ARTICLE 4. PURPOSE(S)**

The purpose(s) of the Corporation is as follows:

This Corporation is a not- for-profit publication ministry organized under Chapter 617, Florida Statutes, exclusively for spreading the Gospel of Jesus Christ, it is not organized for the private gain of any person.

(A.) The specific purpose(s) of this Corporation, Christ Jesus Redeems Forum, A Publication Ministry, is to spread the Gospel of Jesus Christ into the homes, the hospitals, the churches, and community based programs. Christ Jesus Redeems Forum, A Publication Ministry is capable of encouraging readers that have fallen short of the glory of God, and who have committed minor or felony offenses. Informing them of importance of the development of their self-esteem, as well as their spiritual, social, and economical values.

(B.) The purpose(s) of this Corporation, Christ Jesus Redeems Forum A Publication Ministry, is provide a charitable service by soliciting for donations from church ministries and businesses. The donation(s) are to be used to:

(1.) Support Christ Jesus Redeems Forum Ministry to provide a charitable assistance services to men and women (desiring to apply for restoration of Civil Rights, with the state of Florida Rules of Executive Clemency) that have lost their civil rights, due to committing a minor or felony offenses, with the exception of those who have committed capital felony offenses. Buttressed by the evidence that they have completed all post-released conditions of supervision including but not limited to probation, parole, community control, control release and conditional release, and legal restraint that have been imposed on them by the Criminal Justice System.

(C.) The purpose of this Corporation, Christ Jesus Redeems Forum, A Publication Ministry, is not for a private gain. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, this Corporation shall not carry on any other activities not permitted to be carried on (a.) by a corporation exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b.) by a corporation, contributions to which are deductible under Section 170(C)(2) of the Internal Revenue Code, or the corresponding section of any future tax code.

(D.) The purpose of this Corporation, Christ Jesus Redeems Forum, A Publication Ministry, to engage in any and all lawful business purpose(s) and the United States of America upon non-profit corporations.

#### **ARTICLE 5. MEMBERS**

The Corporation shall have voting members, who shall be elected (and may be removed) by the voting members, and who shall have all the rights and privileges of members of the Corporation. The bylaws may provide for non-voting members of one or more classes, who shall be admitted in such manner and who shall have such rights and privileges as are set forth in the bylaws, but who shall not have the right to vote. **ARTICLE 6. INITIAL REGISTERED AGENT AND OFFICE**

**ARTICLE 7. INITIAL BOARD OF DIRECTORS**

The initial Board of Directors shall have three (3) members whose names and addresses are:

Each officer shall be elected by the Board of Directors (and may be removed by the Board of Directors) at such time in such manner as may be prescribed by the bylaws.
