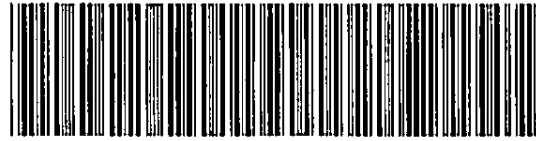



ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FAITH BIBLE CHURCH OF PORT ST. JOE, FLORIDA, INC.

ARTICLES OF INCORPORATION

Pursuant to section 617.1006, Florida Statutes, the Corporation adopts the following Amendments to its Articles of Incorporation of Faith Bible Church of Port St. Joe, Florida, Inc. as follows.

ARTICLE I – NAME

The name of this corporation is Faith Bible Church of Port St. Joe, Florida, Inc., (hereafter referred to as "Faith Bible").

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The principal place of business and mailing address of this corporation is at 801 20th street, Port St. Joe, Florida 32456. The registered agent of this corporation is Michael R. Chisholm at the address indicated in Article VI below.

ARTICLE III – TERM & PURPOSE

This corporation shall have perpetual existence and its commencement shall be effective from date of filing.

Faith Bible is a nonprofit religious corporation. It is organized as a local independent church exclusively for religious and educational purposes, supports the doctrine of the scriptures as set forth in Faith Bible's Doctrinal Statement. Faith Bible also operates a nonprofit Christian School.

The Corporation is to be operated exclusively for charitable, religious, and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its members, directors, trustees, officers, or private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth above. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or

intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of its charter, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under Section 501 (C) (3) of the Internal Revenue Code, or (b) by a corporation, contributions to which are deductible under Section 170 (C) (2) of the Code, or corresponding section of any future tax code.

ARTICLE IV-DIRECTORS/BOARD OF TRUSTEES

The Directors of Faith Bible shall be the Board of Directors who shall be elected in accordance with the By-laws of Faith Bible.

ARTICLE V - POWERS

The business of this corporation shall be conducted in conformity with the bylaws as the same now exists or as may be hereafter amended, changed or modified.

In addition to the powers and duties granted herein and by the Bylaws, Faith Bible assumes for itself all the rights, powers, and privileges and immunities which are now, and which may be during the existence thereof be conferred by law upon corporations with a similar character.

ARTICLE VI-REGISTERED AGENT

The name and Florida street address of the initial registered agent shall remain Michael R. Chisholm and his address is 1106 Long Avenue, Port St. Joe, Florida 32456.

ARTICLE VII-NAMES AND ADDRESSES OF BOARD OF DIRECTORS

ARTICLE VIII – CORPORATE MEMBERSHIP

The corporation shall have members. Upon the filing of these Articles of Amendment to the Incorporation, the members of the Faith Bible Church of Port St. Joe, Florida shall be members of this corporation. Only those members of the Faith Bible, are entitled to vote at a meeting of the members.

ARTICLE IX - TERM

The Faith Bible shall exist in perpetuity. If for any reason Faith Bible shall be abandoned, discontinued, or cease to exist as a legal entity and its charter shall expire or be terminated, the title to all of its property shall be transferred to an organization qualified under Section 501 (C) (3) of the Internal Revenue Code.

IN WITNESS WHEREOF, we the undersigned Directors have adopted these Amendments to Articles of Incorporation with approval of the membership as well as the Directors of this Non-Profit Corporation and we have hereunto set our hand and seal this 13th day of November 2017, for the purpose of Amending these Article of Incorporation, not for profit, under the laws of the State of Florida and I hereby make and file in the office of the Secretary of State, State of Florida, these Amendments to Articles of Incorporation and certify that the facts herein stated are true.
