SECOND AMENDMENT TO ARTICLES OF INCORPORATION

OF

## STORETARY OF AN IO. 41 FRIENDS OF THE WESTERN COMMUNITIES CENTER FOR THE ARTS, IF

WHEREAS, Friends of the Western Communities Center for the Arts, Inc., is a Florida notfor-profit corporation; and

WHEREAS, Article XVI of the Articles of Incorporation of Friends of the Western Communities Center for the Arts, Inc. (sometimes referred to as the "Corporation"), provides in part that the Board of Directors have the authority to propose amendments to the Articles of Incorporation in accordance with the laws of the State of Florida; and

WHEREAS, no members of the Corporation are entitled to vote on a proposed amendment to the Articles of Incorporation; and

WHEREAS, on September 25, 1996, the Board of Directors, at a duly called Board meeting, did unanimously vote their approval to amend Article IV of the Articles of Incorporation to comply with Section 501(c)(3) of the Internal Revenue Code.

NOW, THEREFORE, be it resolved that pursuant to said Article XVI of the Articles of Incorporation of Friends of the Western Communities Center for the Arts, Inc., the Articles of Incorporation are hereby amended as follows:

- 1. The Article IV of the Articles of Incorporation of Friends of the Western Communities Center for the Arts, Inc., are hereby amended to add the following provisions:
  - Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.
- The foregoing Amendment was approved and adopted by the unanimous vote of the 2. Board of Directors of this Corporation on September 25, 1996.
- In all other respects the Articles of Incorporation shall remain the same. 3.
