ARTICING OF INCORPORATION OF

AT-RISK YOUTH CENTER OF SOUTH FLORIDA INC

The undersigning, acting as incorporation of a corporation of a profit under the State of Florida Not For Profit Corporation Act, adopts the following Articles of Incorporation for such corporation.

ARTICIES I-NAME AND ADDRESS

The name of this corporation is: At-Risk Youth Center of South Florida Inc.

ARTICLE_II-PRINCIPAL_PLACE_OF_BUSINESS
AND_MAILING_ADDRESS

The mailing address and the address of the principal office of this corporation shall be:

ARTICLE_III-PURPOSES

This corporation is organized exclusively for charitable, educational, disciplinary and physical purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of 1986, as amended (the "code"). These purposes are as follows:

(1) To receive and maintain a fund or funds and to apply the income and principal thereof for charitable and educational purposes, within the United States of America; and more particularly, but without limiting the generality of the forgoing, to organize, construct, and operate a Center to help minority youths who are endanger of becoming school dropouts, or have developed a disregard for adult rules and regulations, and are at risk for becoming juvenile delinquents or victims of the streets in Dade County and abroad in Florida to expand and develop their minds and bodies through education such as tutoring, sports and sports activities, along with counseling through companionship; to also assist the community, especially the lower income and single parent families in designing and implementing "Health and Human Services Programs" to make and receive gift or gifts to other corporations or associations organized and operated exclusively for charitable and educational purposes; generally to carry on either alone or in cooperation with other any and all activities in furtherance of one or more of the said purposes;

- (2) To take and hold by bequest, devise, gift, purchase or lease, whether absolutely or in trust, for any of its purposes, and any property, real or personal, without limitations to amount or value; to sell, convey and dispose of any such property and to invest and reinvest the income and principal thereof, and to deal with and expend the income and the principal of the corporation for any of the purposes hereinbefore set forth; and
- (3) To do all things necessary or appropriate in order to accomplish the foregoing purposes.

This corporation shall possess all powers and authority permitted by law, except:

- (1) No part of the net earning of the corporation shall inure to the benefit of, or be distributed to, its members, Trustees, officers or other pricate persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments in furtherance of the purposes set forth in this Articles III; and
- (2) No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and this corporation shall not participate in, or intervene in, (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office; and
- (3) Notwithstanding any other provision of these Articles of Incorporation, this corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501 (c)(3) of the Code, or the Code, or (b) by a corporation, contributions to which are deductible under Section 170 (c)(2) of the code.

ARTICLE IV APPOINTMENT OF DIRECTORS

The members of the Board of Directors of this corporation are appointed by a committee made of community representatives interested on the welfare and charitable and economic development of the underprivileged male youths in South Miami and in the State of Florida; such as Businesses, Corporations, Parents, etc. The corporation shall have open membership. Membership maximum dues is 100.00 dollars per year, minimum membership is 2.00 dollars per month.

ARTICLE V QUALIFICATION
