The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is **Medical Cannabis Advocates of Key West, Inc.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 517 Whitehead St., Key West, FL 33040.

ARTICLE III: PURPOSE

The specific nature of business of this corporation is to Advocate Medicinal use of Marijuana.

ARTICLE IV: QUALIFICATION

The qualifications for members and the manner of their admission are stated in the bylaws of the corporation.

ARTICLE V: INITIAL REGISTERED OFFICE AND AGENT

ARTICLE VI: INITIAL BOARD OF DIRECTORS

ARTICLE X: AMENDMENTS


The corporation reserve the right to amend or repeal any provisions of these Articles of Incorporation, or any amendment(s) thereto.
