

SCHEDULE OF AMENDMENTS TO THE ARTICLES OF INCORPORATION OF BUCKHORN RIDGE HOMEOWNERS ASSOCIATION, INC.

- 1. ARTICLE XI AMENDMENT OF ARTICLES, paragraphs A(2) and (3) of the Articles of Incorporation shall be amended to read as follows:
 - (2) A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by not less than $\frac{\text{one-third }(1/3)}{\text{one-fourth }(1/4)}$ of the voting members of the Association.
 - (3) Except as elsewhere provided, an amendment shall be adopted if approved by not less than two-thirds (2/3) of the Lot owners. a majority of the members present, in person or by proxy, at a meeting called for the purpose of voting on said amendment.
- 2. ARTICLE XI AMENDMENT OF ARTICLES, is amended by adding an entirely new paragraph A(4) to read as follows:
 - (4) For the purpose of this paragraph, a voting member is an owner of a Lot within the Community otherwise entitled to vote under the requirements of the governing documents. There shall not be more than one vote cast per Lot.
