ARTICLE ONE Name

The name of the Corporation is AFRICAN AMERICAN CHAMBER OF COMMERCE OF NORTH FLORIDA, INC.

ARTICLE TWO Principal Office and Address

The address of the principal office of the corporation is 1817-A North Myrtle Ave, Jacksonville, Florida, 32209 and the mailing address of the corporation is the same.

ARTICLE THREE Duration

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State Florida.

ARTICLE FOUR Purpose

The Corporation is organized to advance the general welfare and prosperity of African American businesses in Duval county so that all citizens in this community shall prosper. All necessary means of promotion shall be provided and particular attention and emphasis shall be given to the economic, civil, commercial, industrial and educational interests of African American businesses in this areas.

ARTICLE FIVE **Directors**

ARTICLE SIX Registered Office and Agent

The initial registered office of the Corporation shall be 1817-A N Myrtle Avenue Jacksonville, Fl 32209. The initial registered agent of the Corporation at that address shall be Lewis Siplin.

ARTICLE SEVEN Earnings and Activities of the Corporation

No part of the net earnings of the Corporation shall inure to the benefits of, or be distributable to its members, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions.

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or a corresponding section of any future Federal tax code, or shall be distributed to the Federal, state or local government for public purpose. Any such assets not disposed of by a Court of competent jurisdiction in the county in which the principal office of the Corporation is them located, exclusively for such purpose or to such organizations as such Court shall determine, which are organized and operated exclusively for such purposes.
