ARTICLES OF INCORPORATION OF CALVARY CHAPEL CHRISTIAN FELLOWSHIP, INC.

FIRST: The name of the corporation is Calvary Chapel Christian Fellowship, Inc. 28651 Fairweather Drive Wesley Chapel, FL 33543

SECOND: The corporation's purposes are:

- (a) Primarily to engage in the specific business of operating a local church;
- (b) To engage in the business of establishing and maintaining a church, providing a place of public worship for the same in or near the area known as "New Tampa," County of Hillsborough, State of Florida, to establish, maintain and conduct schools for the religious instruction of the young, to further other religious and charitable work, to sue and be sued in its corporate name, to make contacts and to receive property by devise or bequest, subject to the laws regulating the transfer of property by will;
- (c) To carry on any business whatsoever which this corporation may deem proper or convenient in connection with any of the foregoing purposes or otherwise, to borrow money, to lend money, to own real property, to own personal property, to have and exercise all the powers conferred by the laws of the State of Florida upon corporations formed under the laws pursuant to and under which this corporation is formed, as such laws are now in effect or may at any time hereafter be enacted or amended;
- (d) To engage in any business related or unrelated to those described in clauses (a), (b), and (c) of the Article SECOND and from time to time authorized or approved by the board of directors of this corporation;
- (e) To act as partner or joint venturer or in any other legal capacity in any transaction; and
- (f) To do business anywhere in the world.

The above purpose clauses shall not be limited by reference to or inference from one another, but each such purpose clause shall be construed as a separate statement conferring independent purposes and powers upon the corporation.

THIRD: The county on the State of Florida where the principle office of the transaction of the business of the corporation is in the County of Hillsborough, State of Florida.
