

ARTICLES OF INCORPORATION

OF

FRIENDS OF LAKE KILLARNEY, INC.

The undersigned, acting as incorporator of this corporation pursuant to Chapter 617 of the Florida Statutes, hereby forms a corporation not for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

ARTICLE I - NAME OF CORPORATION

The name of this corporation shall be FRIENDS OF LAKE KILLARNEY, INC.

ARTICLE II - ADDRESS OF PRINCIPAL OFFICE

AND MAILING ADDRESS OF CORPORATION

The address of the principal office of the corporation is 201 W. Canton Avenue, Suite 150, Winter Park, Florida, 32789, and the mailing address of the corporation is 201 W. Canton Avenue, Suite 150, Winter Park, Florida, 32789.

ARTICLE III - PURPOSES AND POWERS OF CORPORATION

A. The corporation is organized exclusively not for pecuniary profit, for charitable, benevolent, eleemosynary, educational, historical, civic, social, cultural and scientific purposes. To the extent consistent with the preceding sentence
