ARTICLES OF INCORPORATION



OF

The undersigned, desiring to form a "Not-For-Profit corporation for the purposes hereinafter stated under and pursuant to the laws of the State of Florida, do hereby declare as follows:

ARTICLE I.

The name of the corporation shall we:

ARTICLE II.

The nature of the business wich may be transacted by the corporation is as follows:

This corporation may engage in any activity or business permitted under the laws of the State of Florida, and shall enjoy all the rights and privileges of a corporation granted by the laws of the Stat of Florida.

ARTICLES III.

The purposes of this Corporation shall be:

- A) To represent the Haitian-American Community and to promote its human, civil and political rights.
- B) To create a solid network of information and organization for community action.
- C) To foster economic, cultural and educational programs for all Haitians.
- D) To promote success in political, economic, social and cultural achievements.
- E) To educate all Haitians-American Citizens of their participation in political actions, such as registering to vote in the local, State and national elections in the USA.
- F) To use all legal and appropriate means to achieve the goals and purposes of the Organization.

ARTICLE IV. BOUNDARIES

The Headquater of the Corporation shall be in the city of Delray Beach, County of Palm Beach, State of Florida.

ARTICLE V. PRINCIPAL OFFICE

The principal office or place of business of the corporation shall be located at 510 SW 8TH Avenue, Delray Beach, Florida 33444, with the privilege of having its offices and branch offices at other places within the State of Florida.

ARTICLE VI. PROFIT

This corporation is operated exclusively as a "NOT-FOR-PROFIT" Corporation in accordance with the requirements of Section 501 (C) (3) of the Intenal Revenue Code of 1954 (or the corresponding provisions of any future United States Internal Revenue rule or regulation), and shall be subject to the following requirements:

No part of the net earnings of the organization shall inure to the benefit of or be distributable to its members, director, officers or other private person, except that the Corporation shall be empowered to pay reasonable compensation for services rendered by its employees such as Executive Director, clerks and contractors.

ARTICLE VII. BOARD OF DIRECTORS

The Corporation shall at an annual General Assembly, elect eleven directors and officers and an Advisory Board.

ARTICLE VIII.

This Corporation shall commence to exist on the date of the execution and acknowledgement of the articles if permitted by law; if not, then on the date of filing. This Corporation shall exist perpetually thereafter, unless sooner dissolved according to law.

ARTICLE IX. DISSOLUTION

If for any justifiable reason, the corporation shall cease to exist; any remaining assets shall be giving to a similar corporation with the same purpose and was qualified as an exempt corporation in regard to Section 501 (C) (3) of the Code.
