ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

Name

The name of the corporation shall be:

ARTICLES II

Principal place of business and mailing address

Principal place of business and mailing address of this corporation shall be: 16450 Northwest 20th Avenue, Miami, FL 33054.

ARTICLES III

Purposes

The specific purposes for which the corporation is organized are: The Corporation may engage in or transact any or all activities or business permitted under the laws of the United States and of the State of Florida. The Corporation shall exist perpetually.

The Corporation shall serve as a source for fund-raising to promote the cultural arts under the service mark of *The Urban Theater Series* and its related projects. The Corporation shall assist in providing financial stability to *The Urban Theater Series* and its related projects in order to provide a variety of cultural arts activities for the community. The corporation shall seek potential community and national resources to fund *The Urban Theater Series* and its related projects. The corporation may partner with community and corporate entities for the purpose of developing special cultural arts programs that would best serve the community and the goals of *The Urban Theater Series* and its related projects. These events or projects may sometimes be marketed under the service mark of "*The Urban Theater Series*" or "*The Urban Arts Series*" or any other service mark.

The main purpose of the Corporation is to create and foster the promotion of cultural arts projects for the citizens of the State of Florida. Special emphasis shall be made to involve the youth, senior citizens, and the underserved sectors of the community.

Article IV

Manner of election of directors

The manner in which the directors are elected or appointed is as follows: The method of election of directors is stated in the bylaws.

ARTICLES V

Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes.




