# ARTICLE I

# NAME

The name of the Corporation is SUNNY HILLS CRIME PATROL, INC.

#### ARTICLE 2

# DURATION

The duration of the Corporation is perpetual.

#### ARTICLE 3

# **PURPOSES**

The purpose of the corporation is as follows:

- A. This corporation is a not-for-profit corporation organized under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purpose of this corporation shall be performing periodic patrols of the Sunny Hills area to deter any acts or violation of existing laws.
- B. The exercise all rights and powers conferred by the laws of the State of Florida upon nonprofit corporations.

# MEMBERS

The Corporation shall have Voting Members, who shall be elected (and may be removed) by the Voting Members, and who shall have all the rights and privileges of members of the Corporation. All members shall be residents of the community known as Sunny Hills, Washington County, Florida, or of any other area serviced by this organization, who is of sound mind and body, and who has attained the age of eighteen (18) and who is in good repute in the community. All active members shall be required to perform assigned patrol duties.

#### ARTICLE 5

#### ARTICLE 7

# **OFFICERS**

The officers of the Corporation shall consist of a President, Vice-President, Secretary, Treasurer and Captain. Other officers may be provided for in the By-Laws. ### ARTICLE 8

#### NONSTOCK BASIS

The Corporation is organized (and shall be operated) on a nonstock basis within the meaning of the Florida Not For Profit Corporation Act, and shall not have the power to issue shares of any type or class of stock, but may issue membership certificates if so provided in the By-Laws.

# ARTICLE 9

# EARNINGS AND ACTIVITIES OF CORPORATION

- A. No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set for in Article 3 hereof.
- B. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.
- C. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).
- D. Notwithstanding any other provision of these Articles, this corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this corporation.
