*Pursuant to the provisions of section 617.1007, Florida Statutes, the undersigned Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation.*

**FIRST: Amendment (s) Added and Adopted**

**ARTICLE II, PURPOSE**

1. To establish ministries of help.

A. To Operate an Outreach Center named Community Life Center

1. To provide services to help individuals and families in crisis and lack with food, budget counseling, financial aid and any and all services to help individuals and families regain their self sufficiency and life of wholeness both physically, socially, mentally and spiritually.
2. To establish a Board of Directors for said Outreach Center.

**SECOND: Amendment (s) Removed**

7. To establish a Church named Community Life Worship Center

- A. Providing a place of worship, a place of fellowship, a place of discipleship and a place of training for children, youth, parents and those of faith in our Saviour Jesus Christ.
- B. To Ordain followers of Christ and Develop and establish ministries to reach the world.
- C. Conducting a local church by the direction of the Lord Jesus Christ and under the leadership of the Holy Spirit as set forth in the Holy Bible, the irrevocable Word of God. Pursuant thereto, the following activities and guidelines shall be established:
  1. A recognized Creed, Code of Doctrine, discipline and form of worship shall be established
  2. An ecclesiastical form of government shall be established.
  3. A church membership based upon acceptance of a recognized creed and belief and support of the church shall be established.

9. To establish other ministries which promote wholesome and Godly living to those of faith.


