The name of the corporation (hereinafter called "the Corporation") is The Locander Foundation, Inc.

Section 1 - Office

The duration of the Corporation is perpetual with the principal office being in the State of Florida and shall be located in Hillsborough County, at 6303 MacLaurin Drive, Tampa, FL 33647

Section 2 - Other Offices

Other offices for the transaction of business shall be located at such places as the Board of Trustees may from time to time determine.

AKTICLE II MLS.SION .STATEMENT

To provide financial assistance to deserving individuals in the form of scholarships, grants and awards to assist them in pursuing their educational goals at the field of marketing and leadership.

The Corporation is organized exclusively for charitable purposes, within the meaning of these terms used in Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future Internal Revenue

II. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. Notwithstanding any other provision of these articles, the Corporation shall not carry on any activities not permitted to be carried on (a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

Section 3 - Liability of Members

No member of the Corporation shall be personally liable for any of its debts,

liabilities, or obligations. However, members may be required to pay annual dues as determined by the Board of Trustees.

POURD OF TRACTICES

The management of the affairs of the Corporation is vested in the Board of Trustees which is elected or appointed in accordance with the Bylaws. The of Trustees shall consist of no fewer than three (03) and not more than fifteen (15) trustees.
