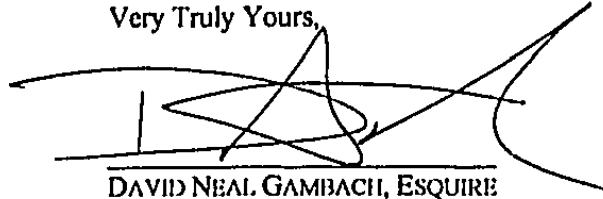

ARTICLE I  
CORPORATE NAME & ADDRESS

The Name, Principal Office, and Mailing address of this corporation shall be:

ARTICLE II  
NATURE OF CORPORATE BUSINESS

(a) The Corporation is organized and shall be operated exclusively for the promotion of social welfare within the meaning of Sec. 501(c)(4) of the Internal Revenue Code and its Regulations as they now exist or as they may be hereafter amended, and it is authorized to receive and maintain funds, to change the investments thereof, to invest and reinvest the proceeds thereof, and to collect and receive the income and profits thereof, and to apply the income and principal to the aid and assistance of the Corporation to promote social welfare, and to do all things that may be necessary and useful in the accomplishment of the purposes hereinabove set forth.

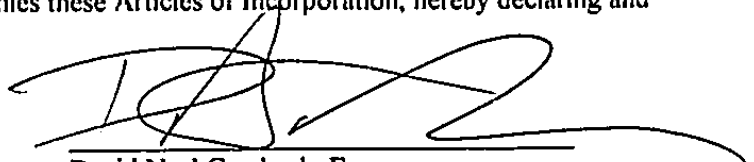
