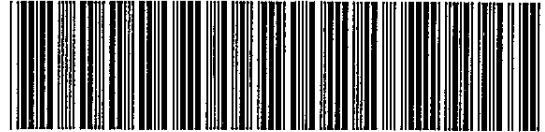

Pursuant to the provisions of the Florida Not For Profit Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is BLUE ANGELS CLASSIC FOUNDATION, INC., a Florida corporation.

SECOND: The corporation has no members. The following amendment to the corporation's Articles of Incorporation was unanimously adopted by the Board of Directors of the corporation on September 10, 2003, said vote sufficient for approval, in the manner prescribed by the Florida Not For Profit Corporation Act:

**ARTICLE I - NAME**


