ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF ISLAMIC SOCIETY OF ORLANDO, INC.

Pursuant to the provisions of Section 617.1002 of the Florida Statutes, the undersigned Florida corporation hereby adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I - NAME

The name of the corporation is Islamic Society of Orlando, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - ADOPTION AND TEXT OF AMENDMENTS

and Article III of the Articles of Incorporation by Written Consent dated March 30, 2007, in accordance with the provisions of Section 617.0821 of the Florida Statutes. RESOLVED, that Article I of the Articles of Incorporation of the Corporation be amended in its entirety to read as follows:

"ARTICLE I

NAME OF CORPORATION, MAILING ADDRESS AND ADDRESS OF PRINCIPAL OFFICE

The name of this corporation shall be ISLAM, Inc. The mailing address of the corporation is P. O. Box 338, Goldenrod, Florida 32733-0338. The principal office of this corporation shall be 1586 N. Goldenrod, Road, Suite A, Orlando, Florida 32807-8306."

FURTHER RESOLVED, that Article III of the Articles of Incorporation of the Corporation be amended by deleting the entire first paragraph thereof and substituting the following therefor:

"The primary purpose for which this Corporation is formed is to establish Islamic places of worship for persons of the Muslim faith, and to provide reliable information regarding the religion of Islam."
