The undersigned, acting as Incorporator(s) of a Corporation, pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation of such corporation:

ARTICLE I

The name of the corporation shall be: R.B. STUCCO SERVICES, INC.
(alternative: ROBERT BING STUCCO SERVICES, INC.)

The principal place of business of the corporation shall be: 704 14th Street, East, Palmetto, Florida 34221.

ARTICLE II

The period of the duration of this corporation is perpetual unless dissolved according to law.

ARTICLE III

The purpose (purposes) for which the corporation is organized is to provide masonry (stucco) services related to the construction field. As well as build construct any property in any manner not prohibited by law.

ARTICLE IV






