I, the undersigned, being a natural person, competent to contract, and acting as an incorporator, do hereby subscribe to the following Articles of Incorporation for the purpose of creating a Nonprofit Corporation under Florida Statute 617.

ARTICLE I - CORPORATE NAME

The name of the Corporation is:

ARTICLE II - DURATION

The duration of the Corporation is perpetual.

ARTICLE IV - PURPOSE

This corporation is a not-for-profit corporation organized Under Chapter 617, Florida Statutes. It is not organized for the private gain of any person. The specific purposes of this corporation are

- C. To promote goodwill & sportsmanship and the common Interest among members through sports, music, mentoring Programs targetting young girls and boys.

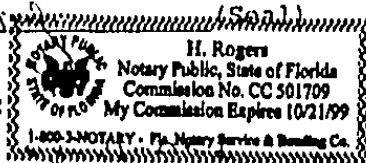

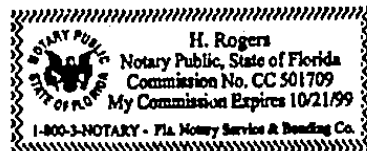
