# ARTICLES OF INCORPORATION

*The undersigned, acting as Incorporator(s) of a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:*

## ARTICLE I

### Name

The name of the corporation shall be: Florida Sovereignty Land Council, Inc.

## ARTICLE II

### Principal place of business and mailing address

The principal place of business and the mailing address of this corporation shall be:

245 Quayside Circle, Maitland, Florida 32751

## ARTICLE III

### Purpose(s)

The specific purpose(s) for which the corporation is organized is (are): to do all things that are lawful and proper to: protect and preserve Florida sovereignty lands, including their public ownership and use by all the people of Florida for their lawful outdoor sports and recreation; protect and preserve Florida wetlands from environmental harm; protect and preserve the quality of Florida's water supply, particularly that naturally filtered by Florida's wetlands; protect Florida's public wetlands from exploitation by commercial enterprises. To inform the people of Florida concerning these matters by appropriate publications.

## ARTICLE IV

### Manner of election of directors

The manner in which the directors are elected or appointed is as follows:

There shall be not less than 3, nor more than 5 directors. The directors shall be elected by the Trustees. The initial incorporators shall be the initial Trustees, who shall serve as Trustees until their successors are elected by the Trustees. Trustees shall serve for an indefinite period of time, which shall be concluded individually and respectively by resignations from time to time.


ARTICLE VII


