### ARTICLE III PURPOSE(S)

The specific purpose(s) for which the corporation is organized is (are):

The general nature of the object of this corporation is to conduct for religious worship and instruction, churches, church schools, parsonages, and other related institutions and activities connected therewith of a religious, educational, charitable and benovolent character to the end that its own members and others may be generally instructed and guided in the Christian faith as perpetuated and promulgated in and by the Doctrines and teachings of the Church of God Reformation Movement, whose general agencies and offices are located at Anderson, Indiana; to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located and elsewhere; and to promote home and foreign missions.

ARTICLE VI LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

The Corporation shall not distribute any part of its income to its members, directors, officers or other private persons, except that the Corporation may pay compensation in a reasonable amount to its members, directors, officers and employees for services rendered in furtherance of the purposes set forth in Article 3 hereof.

No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code, or corresponding Section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the Corporation, after paying or making provisions for the payment of all liabilities of the Corporation, assets shall be distributed to the Board of Church Extension and Home Missions, with corporate offices at Post Office Box 2069 in Anderson, Indiana 46018-2069, for its general uses and purposes; provided, that such corporation is organized and operated

exclusively for charitable, educational, religious, or scientific purposes and that shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, and if not, then to one or more organizations that are organized and operated exclusively for charitable, educational, religious, or scientific purposes and that shall at the time qualify as an exempt organization under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of the Corporation is then located, exclusively for the purposes or to the organization or organizations as said court shall determine are organized and operated exclusively for charitable, educational, religious, or scientific purposes.

C H A R T E R

FIRST CHURCH OF GOD, OSPREY, FLORIDA

ARTICLE I.

The name of the corporation shall be "FIRST CHURCH OF GOD, OSPREY, FLORIDA", and it to be located in Osprey, Sarasota County, Florida.

ARTICLE II.

The general nature of the object of this corporation is to conduct for religious worship and instruction, churches, church schools, personages, and other related institutions and activities connected therewith of a religious, educational, charitable, and benevolent character to the end that its own members and others may be generally instructed and guided in the Christian faith as perpetuated and promulgated in and by the Doctrines and teachings of the Church of God Reformation Movement, whose general agencies and offices are located at Anderson, Indiana; to advance spiritual growth and enlightenment, moral and personal purity among its own membership and the people of the community in which it is located and elsewhere; and to promote home and foreign missions.

The corporation shall have the power to acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, incumber, sell, convey, and dispose of all such property in conformity with the By-Laws of the First Church of God, Osprey, Florida; and the corporation shall have the power to erect and maintain buildings for the worship of God, for training in Christian faith and conduct, and to acquire or build and maintain residences for the use and occupancy of its ministers.









ARTICLE XII.

It is intended by this incorporation of the First Church of God, Osprey, Florida, to fully protect and exempt from any and all legal liability the individual officers and members, jointly and severally, of the First Church of God, Osprey, Florida, for and on account of the debts, liabilities, and other obligations, of every kind and description, of the said First Church of God, Osprey, Florida.
