

## CONSTITUTION AND ARTICLES OF INCORPORATION OF EMMANUEL BAPTIST CHURCH OF ARLINGTON, INC.

(A Corporation Not for Profit)

We, the undersigned, with other persons being desirous of forming a corporation not for profit for religious, educational, charitable and philanthropic purposes, under the provision of the Florida Statues, do agree to the following:

#### ARTICLE I. NAME

The name of the corporation is Emmanuel Baptist Church of Arlington, Inc.

#### ARTICLE II. ADDRESS

The principal place of worship is 3105 North University Boulevard, Jacksonville, Florida, 32211, such other place as the membership may from time to time designate. The mailing address of the corporation is 4251 Monument Road, #104, Jacksonville, Florida 32225.

#### ARTICLE III. PURPOSES

The general nature of the objects and the purposes of this corporation are to praise the triune God of the Holy Bible, proclaim the Gospel of Jesus Christ, provide opportunities for fellowship and support, encourage noticeable spiritual growth among its members, provide opportunities for lay minitury, to evangelize with emphasis on discipleship and church planting within our community, nation and world, to own, acquire, by gift, devise, purchase or otherwise, real and personal property, and to build, erect, construct, provide for, maintain and equip suitable buildings, churches, and houses for the benefit, use and occupation of the Church, its members and congregation, in maintaining and fostering public worship and the preaching and teaching of the Word of God and the Gospel of Jesus Christ, and for all other meetings and purposes of the Church, its members and congregation; to build, construct, erect, maintain and equip schools, mission stations and mission churches, pastors' homes and such other houses as the Church may desire for carrying on its work.

#### ARTICLE IV. BOARD OF DIRECTORS

The activities and affiars of the corporation are to be managed by a Board of Directors consisting of not less than three (3) members who shall serve for the period of time provided in the bylaws and until their successors are elected and qualified. The Board of Directors shall be elected by the members of the corporation at the annual meeting.

The Board of Directors may by resolution designate one or more committees, each to consist of one (1) or more of the directors of the corporation, which, to the extent provided in said resolution or in the bylaws of the corporation, shall have and may exercise the powers of the Board of Directors in the management of the business affairs of the corporation.

#### ARTICLE V. OFFICERS

The <u>officers</u> of the corporation shall be members of the Church and shall be elected by the membership of the Church and shall hold office in accordance with the bylaws. The <u>officers</u> of the Church shall be Senior Pastor, Chairman of Deacons, Church Clerk, and Church Treasurer, and such other officers as the Board of Directors may designate. All officers of the corporation shall hold office for the period of time provided in the bylaws of the corporation and until their successors are elected and qualified. The Senior Pastor shall serve as the President of the Church and shall act as the moderator of the Church. The Chairman of Deacons shall serve as the Vice President of the Church and shall act as the moderator of the Church in the absence of the Senior Pastor. The Church Clerk shall serve as the Secretary of the Church. The Church Treasurer shall serve as the chairman of the Finance Team, church treasurer, and shall act as moderator in the absence of both the Senior Pastor and Chairman of Deacons.

#### ARTICLE VI. BYLAWS

The members of this corporation shall adopt bylaws for the carrying out of its purposes and the conduct of its business as they may deem necessary from time to time. The bylaws of the corporation are to be made, altered or rescinded by a majority of the members of this corporation present at a legally constituted meeting of the membership as provided in the bylaws.

#### ARTICLE VII. REGISTRATION OFFICE AND AGENT

The initial registered office of this corporation is 4251 Monument Road, #104, Jacksonville, Florida 32225, and Judith J. Hampton is the initial registered agent at that address.

#### ARTICLE VIII. INCORPORATORS/TRUSTEES

The <u>Trustees</u> of the Church shall be the Incorporators of the Church. The name and address of each incorporator is:

#### ARTICLE IX. MEMBERS

The members of this corporation shall consist of all persons in full fellowship and good standing of Emmanuel Baptist Church of Arlington, Inc., and such other persons as, from time to time hereafter, may become members as determined by the bylaws.

#### ARTICLE X. AMENDMENTS

Amendments to these Articles of Incorporation shall be subject to adoption by the majority of the members of the Church at any regular or special meeting called for that purpose, in accordance with the bylaws.

#### ARTICLE XI. DISSOLUTION

In the event of the dissolution of this corporation, all of its properties and assets, remaining after payment of all costs and expenses of such dissolution, shall be distributed and paid over in <u>equal amounts to the Elorida Baptist Convention and the Jacksonville Baptist Convention</u>. These organizations are exempt from federal income tax under the provisions of the Internal Revenue Code as it now exists or may hereafter be amended, changed, modified or supplemented. None of the assets will be distributed to any member, officer, or trustee of this corporation.
