The name of this corporation shall be Our Lady of the Sacred Flame, Inc

**ARTICLE II:**

The principal office address shall be located at number 2832 Lancaster Road, Melbourne, Brevard County, Florida, or at such other location as the Board of Directors may, from time to time establish by resolution, and place on file with the Secretary of State of Florida. **ARTICLE III:**

Said corporation is organized for the purpose of operation of a church in which the tenets of the Wiccan religion are supported and taught, to foster and encourage tolerance and interaction between the many differing faiths of the world, to provide and disseminate information regarding this faith to the general public, other religious and secular bodies, and to the print and broadcast media in order to educate and inform, and to promote Wiccan worship, religious education and religious tolerance. 
