ARTICLES OF INCORPORATION
OF
FRIENDS OF BRADLEY'S COUNTRY STORE, INC.

The undersigned incorporator, for the purpose of forming a corporation not for profit under Chapter 617, Florida Statutes, hereby adopts the following Articles of Incorporation.

ARTICLE I

The name of the corporation shall be **FRIENDS OF BRADLEY'S COUNTRY STORE, INC.**

ARTICLE II

The principal place of business and the mailing address of this corporation shall be 9000 Centerville Road, Tallahassee, Florida 32308.

ARTICLE III

The specific purposes for which the corporation is organized is to raise funds and to use such funds to provide maintenance and improvements to the buildings and structures of historical significance located on the Bradley property; to preserve and protect such historical buildings and structures; to obtain recognition from the appropriate groups, societies, associations and governmental authorities as to the historical significance of the Bradley property.

This corporation may transact any and all lawful business for which corporations may be incorporated under Chapter 617, Florida Statutes.

The corporation may also engage in any other activity or business permitted under the laws of the United States of America and the State of Florida.

ARTICLE IV

The affairs of the corporation shall be managed by a board of directors, a president, a vice-president, a secretary and a treasurer. Such officers shall be elected at the first meeting of the board of directors following each annual meeting of members.

ARTICLE V

The corporate powers of this corporation are as provided in Section 617.0302 of the Florida Statutes. Membership shall be as set forth in the By-Laws.

ARTICLE VI

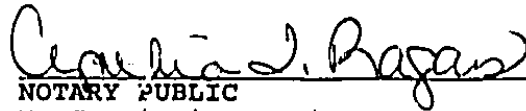

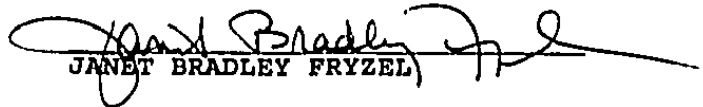
