I, the undersigned incorporator, hereby make, subscribe, acknowledge, and file with the Department of State of the State of Florida these Articles of Incorporation for the purposes of forming a corporation not for profit in accordance with the laws of the State of Florida.

ARTICLE I

Name

Existence

This corporation shall have perpetual existence, and its existence shall commence October 25, 1994.

ARTICLE III

Powers and Purposes

This corporation is for such civic purposes as will qualify it as an exempt organization Section 501(c)(3) of the Internal Revenue Code of 1986 or corresponding provision of any subsequent federal tax laws.

Within the scope of the foregoing, the corporation is specifically organized for the purpose of engaging in charitable and civic purposes.

ARTICLE IV

Membership in the Organization

The manner of admission of members and the rights and duties of the members shall be provided for in the corporation's by-laws. The directors shall be appointed as stated in the bylaws.
