FIRST: The name and address of this corporation is **AMERICAN BRAZILIAN ASSOCIATION CORP.**, a not for profit corporation, 2303 Southwest 18 Avenue, Fort Lauderdale, Florida 33315.

SECOND: The date of the adoption of these Articles of Dissolution is April 11, 1997.
