

ARTICLES OF INCORPORATION OF MINISTERIO MUSICAL MANANTIALES DE VIDA, INC. A NON-PROFIT ORGANIZATION

The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: Ministerio Musical Manantiales de Vida, Inc.

ARTICLE II Principal place of business and mailing address
