ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I - Name

ARTICLE III - Purpose(s)

The specific purposes for which the corporation is organized are:

ARTICLE IV - Manner of election of directors.

The method of election of directors shall be stated in the bylaws of this corporation.

ARTICLE V - Limitation of corporate powers

The corporate powers of this corporation are as provided in section 617.0302, Florida Statutes, unless limited as follows:

The Círculo de Oración de Orlando, Inc. (Circle of Prayer of Orlando, Inc.), is to have the power to do any and all things necessary or expedient for carrying out the purposes of this corporation, and in general to possess all rights, privileges and immunities, and to enjoy all the benefits granted to corporations of similar characters under the laws of the State of Florida. These powers shall include, but not be limited to:

1. Erect, purchase, enter into a lease agreement, and maintain and upgrade, church buildings, social halls, business offices, and such other structures deemed necessary to carry out the overall purposes of this corporation.
2. Collect, solicit, and accept funds, gifts, and other subscriptions necessary to purchase, lease and maintain all facilities used for the stated purposes of this corporation as a nonprofit organization.
3. Publish Christian news, conduct Bible studies, church services, perform all Christian religious services including the rites of marriage and baptism, as well as any other activities and programs of Christian nature admissible by law.
4. Conduct all other powers necessary to carry out the general and specific purposes of the corporation.
