ARTICLES OF INCORPORATION

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statuten, adopt the following Articles of Incorporation of such a corporation:

ARTICLE 1

The name of the Corporation shall be Jacksonville Aquarians Synchronized Swimming, Inc.

Its principal place of business shall be

ARTICLE II

The period of the duration of the Corporation is perpetual unless dissolved according to law.

ARTICLE III

The purpose for which the Corporation is organized is exclusively religious, charitable, scientific, literary, or educational within the meaning of Section 501(c)(3) of the Internal Revenue Code. In fulfilling its purpose, the Corporation will provide instruction in synchronized swimming and arrange amateur competition with similarly organized groups. Notwithstanding any other provision of these Articles, the Corporation shall not conduct any activities not permitted an organization exempt from Federal income tax under Section 501(c)(3) of the Internal revenue Code.

ARTICLE IV

Membership in the Corporation shall be open to all individuals who (1) request membership and pay the membership fees, if any, prescribed by its Board of Directors, (2) are of good moral character, and (3) have an interest in furthering the purpose of the Corporation.

ARTICLE V

The initial Board of Directors will govern the Corporation until the procedure for election under its By-Laws takes effect. The Board shall consist of four persons. The names and addresses of those serving initially are as follows:

ARTICLE VII
