ARTICLES OF AMENDMENT TO
THE ARTICLES OF INCORPORATION OF
LITTLE HAVANA COMMUNITY TEAM INC.

Pursuant to the provisions of Section 617.1001 of the Florida General Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Little Havana Community Team, Inc.
2. Article One (1) of the Articles of Incorporation of Little Havana Community TEAM, Inc is hereby amended to read:

1. The name of the corporation is:

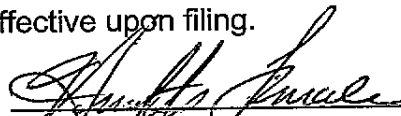
COMMUNITY T.E.A.M., INC.

3. A new Article, Article XI be added to the Articles of Incorporation, and shall read as follows:


4. The foregoing Amendment was adopted by all of the Directors and Officers of this corporation on the 12th day of February, 1999. There are no members entitled to vote.

5. This Amendment shall become effective upon filing.

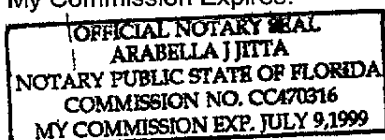

STATEMENT OF INTENTION TO AMEND
ARTICLES OF INCORPORATION OF
LITTLE HAVANA COMMUNITY TEAM., INC.

Pursuant to Florida Statutes Section 617.1001 Humberto Finale being the Chairman hereby manifests its intention to amend the Articles of Incorporation in order to change its name.

At a meeting of the Board of Directors of Little Havana Community Team, Inc., held on February 12, 1999, there being no members entitled to vote, the directors voted as follows:

RESOLVED that the proposed amendment to the Articles of Incorporation of Little Havana Community Team, Inc. changing its name to "Community T.E.A.M., Inc.," be filed with the Secretary of State for the State of Florida.

RESOLVED that Little Havana Community Team, Inc., shall henceforth be known as Community T.E.A.M., Inc. and the Articles of Incorporation of Little Havana Community Team., Inc. shall be amended to reflect the new name.

RESOLVED, that the Articles of Incorporation of Little Havana Community Team, Inc., be amended by the addition of the following new Article XI:

"Article XI Upon dissolution of this corporation its assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, i.e. charitable, educational, religious or scientific, or corresponding section of any future federal tax code, or shall be distributed to the Federal government, or to a state or local government for a public purposes."
