**ARTICLES OF INCORPORATION
OF

- ONE: The name and address of this principal corporation is DEE' VINE DESIGN, INC., 718 Chatelaine Blvd. East, Delray Beach, FL 33445. The Corporation is organized pursuant to the Palm Beach County Nonprofit Corporation Code.
- TWO: This corporation is a nonprofit mutual benefit corporation and is not organized for the private gain of any person. The corporation organized under the Nonprofit Mutual Benefit Corporation Law, for charitable and educational purposes to aid the poor and disadvantaged individuals and families towards a life of self-sufficiency. The programs will consist of, but shall not be limited to: Seminars, Worship Service, Outreach Advocacy Program for The Homeless and Disadvantaged, Health Care, Housing, Employment, Literacy, Counselling, Temporary Shelter, Teenage Pregnancy, Job Training, Job Placement and Acquisition, Substance Abuse Awareness and Prevention, Tutoring, AIDS Awareness, Elderly Care and other programs to aid those in need.
- THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.
- FOUR: The address of the registered office is, 718 Chatelaine Blvd. East, Delray Beach, FL 33445. The registered agent at said office is Barbara Brown.
- FIVE: This corporation is organized and operated exclusively for Educational and Charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.
