ARTICLES OF INCORPORATION

ARTICLE I. CORPORATE NAME.

The name of this corporation is World Perression Festival - Fort Lauderdale, Inc.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation are:

ARTICLE III. CORPORATE PURPOSES.

The purpose of this corporation is to organize and present musical affairs to as wide a public audience as possible, and for such other charitable, religious, educational, scientific, cultural and literary purposes as may qualify under Chapter 617 of the Florida Statutes and Section 501(c)(3) of the United States Internal Revenue Code, or the corresponding section of any future federal tax code, including the making of distributions to other such organizations.

ARTICLE IV. DIRECTORS.

The affairs of this organization shall be directed by a Board of Directors. The initial Board shall consist of the following three (3) individuals:

The Directors shall adopt By-laws for the governance of the corporation within ninety (90) days of filing these Articles. Such By-laws shall provide for the succession, election, and term of subsequent boards, and may provide for any greater number of directors. The Directors shall be appointed from the community at large, and shall consist of persons who have demonstrated an interest in the above stated purposes of the corporation.

ARTICLE V. LIMITS OF CORPORATE POWERS.

Activities of this corporation shall be limited to those charitable, religious, educational, scientific, cultural and literary activities permitted to (a) a corporation exempt from federal income tax under section 501(c)(3) of the United States Internal Revenue Code, or the corresponding section of any future federal tax code, or (1) a corporation, contributions to which are deductible under section 170(c)(2) of the United States Internal Revenue code, or the corresponding section of any future federal tax code, and it shall be operated as a public charity as described in Section 509(a)(1) of the United States Internal Revenue Code, or the corresponding sections of any future federal tax code.

ARTICLE VI. PROHIBITION AGAINST PRIVATE BENEFIT.

No part of the net income of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except as reasonable compensation for services rendered, and as payments and distributions in furtherance of the purposes set forth in Article III hereof.

ARTICLE VII. PROHIBITION AGAINST POLITICAL ACTIVITY.

No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

ARTICLE VII. DISSOLUTION.

Upon dissolution of the corporation, all assets shall be distributed to such organizations, for such exempt purposes, which qualify at the time of such distribution, within the meaning of section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations as said Court shall determine, which are organized and operated exclusively for such purposes.
