

AMENDMENT NO. 1 TO ARTICLES OF INCORPORATION OF LAKELAND-POLK HOUSING CORPORATION



I, the undersigned, being the Secretary of LAKELAND-POLK HOUSING CORPORATION, a Florida not for profit corporation, hereby certify that the following Amendment No. 1 to the Articles of Incorporation, was duly adopted unanimously by all of the Directors at a meeting duly held by them on the 30 day of September, 2002: There are no members.

AMENDMENT

1. Subparagraphs (a), (e), and (f) which first appear in ARTICLE III are hereby amended in their entirety to read as follows:

ARTICLE III - PURPOSES AND POWERS

The general nature of the objects, purposes, powers and limitations of the Corporation shall be as follows:

- (a) to have among its purposes the provision of decent housing that is affordable to low- and moderate-income persons and/or families primarily located in, but not limited to, Lakeland, Florida and the surrounding areas;
- (e) no part of the net earnings of the Corporation shall inure to the benefit of any member, founder, contributor, or individual, officer or other private person, except that the Corporation may be authorized and empowered to pay reasonable compensation for services rendered and products purchased and to make payments and distributions in furtherance of the purposes hereinafter set forth. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office;
- (f) notwithstanding any other provisions of these Articles, the Corporation shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law;
- 2. In all other respects, all other remaining subparagraphs of Article III and the other Articles of the Articles of Incorporation shall remain as they were prior to this Amendment No. 1 being adopted.
