**ARTICLES OF INCORPORATION  
OF  
GRACEVILLE PEE WEE FOOTBALL ASSOCIATION, INC.**

The undersigned, acting as incorporators of a corporation, pursuant to Chapter 617 of the Florida Statutes, adopt the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of this corporation is GRACEVILLE PEE WEE FOOTBALL ASSOCIATION, INC.

**ARTICLE II**

**PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS**

The principal place of business and the mailing address of the corporation shall be 5263 Cotton Street, Graceville, Florida, 32440.

**ARTICLE III**

**PURPOSE**

(a) The specific and primary purpose for which this corporation is organized is to provide social and recreational activities (specifically football and cheerleading) for the children of Graceville and the immediate surrounding areas.

(b) The general purposes for which this GRACEVILLE PEE WEE ASSOCIATION, INC. is formed are to provide a recreational activity for the children of Graceville and the surrounding area, to obtain suitable practice and game facilities, and to purchase, repair, and maintain sports equipment.

(c) This corporation is organized and operated exclusively for pleasure, recreation, and other nonprofit purposes, and no part of any earnings shall inure to the benefit of any member, director, or officer.

(d) This corporation shall have and exercise all rights and powers conferred upon corporations under the laws of the State of Florida, provided, however, that this corporation is not empowered to engage in any activity that in itself is not in furtherance of its purpose as set forth in subparagraphs (a) through (c) of this Article.

#### ARTICLE IV

##### MANNER OF ELECTION OF DIRECTORS

The directors of the corporation shall be elected annually by majority vote of the membership of the corporation at a meeting duly called and noticed for that purpose.

#### ARTICLE V

##### LIMITATION OF CORPORATE POWERS

The corporate powers of this corporation are as provided in Section 617.0302 of the Florida Statutes.

#### ARTICLE VI

##### INITIAL REGISTERED AGENT AND STREET ADDRESS
