The undersigned, for the purpose of forming a corporation not-for-profit under Chapter 617, of the Florida Statutes and under the Florida General Corporation Act, adopts the following Articles of Incorporation.

**ARTICLE I**

**Name of Corporation**

The name of the not-for-profit Corporation is Flowers & Johnson Teen Connection, Inc. and its address is 4320 S.W. 28TH ST. Hollywood, FL 33023 or such other place of business as shall be designated by the Board of Directors. Its mailing address is P O Box 6715, Hollywood, FL 33021.

**ARTICLE II**

**Purpose**

The general nature of the business and the objects and purposes proposed to be transacted and carried on are any and all activities or businesses permitted under the laws of the State of Florida or under the laws of the United States, and to engage in any other trade or business which can, in the opinion of the Board of Directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business or necessary or desirable in order to accomplish the foregoing.

The purpose of the not-for-profit corporation is to provide money for scholarships raised through grants and fund raising activities for low income, minority high school students so that they may be trained for such professions as medicine, law and engineering and to have

these students perform certain works in their community so as to encourage other students to stay in school and follow in their footsteps. Those receiving scholarships will be required to return to work in their community for a certain time commitment after their education is completed.

There are no members of the organization at the present time other than the directors. The selection of directors and the members is stated in the by-laws of the organization.

### **ARTICLE III**

#### **Directors**

The number of directors constituting the board of directors of the Corporation will not be more than three (3) but shall not be less than three. **ARTICLE V**




