ARTICLE ONE

Name

The name of the Corporation is SO CAN I, INC.

ARTICLE TWO

Principal Office and Address

The address of the principal office of the corporation is 931 Marlboro Drive, DeLand, Florida 32724, and the mailing address of the corporation is the same.

ARTICLE THREE

Duration

The term of existence of the Corporation is perpetual; and the corporate existence will commence on the filing of these articles by the Department of State. In the event of dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of 501(c)(3) of the Internal Revenue Code of 1986, or corresponding sections of any future Federal Tax Code, or shall be distributed to the Federal, State, or Local Government for a public purpose. Notwithstanding any other provisions of these Articles, this organization shall not carry on any activities not permitted to be carried on by the organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue Law or Code.

The method of election of the directors of the Corporation is set forth in the bylaws.
