**ARTICLES OF INCORPORATION
OF
CENTRAL FLORIDA YOUTH SPORTS FOUNDATION, INC.**

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I:

The name of the corporation shall be Central Florida Youth Sports Foundation, Inc.

ARTICLE II:

The principal address of the corporation will be:

ARTICLE III:

The specific purpose of the corporation is to organize a Basketball League for young children in school. The league will be run after school hours.

ARTICLE IV: Election of Directors

The President shall appoint three (3) members in good standing at least three (3) months prior to the annual meeting who shall serve as a Nominating Committee to select the Directors of the corporation who shall be elected at said annual meeting. Eligibility and other procedures will be stated in the bylaws of the corporation.

The initial Board of Directors are stated in ARTICLE VII.

ARTICLE V: Dutie & Powers of Directors

The powers of the Board of Directors will not be limited at this time. The Board will always have the best of interest for the corporation when excercising this power. At this time, that power(s) will include:

- a) hold meetings at times and places as may be deemed proper and necessary
- b) admit, suspend or expel members
- c) appoint committees on particular subjects from members of the board or from the membership of the organization
- d) audit bills and disburse the funds of the organization
- e) print and circulate documents and publish articles
- f) carry on correspondence and communicate with other associations with the same interests
- g) employ agents
- h) remove any or all of the officers of the organization with due cause prior to the termination date of such office
- i) elect substitute directors in the event any director resigns or is removed from office prior to the termination date of such office

As the corporation continues to grow, the Board of Directors will add and/or review these powers authorized.
