The undersigned, for the purpose of forming a not-for-profit corporation pursuant to Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is:

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The corporation is organized for the purpose of evangelism and ministration.

ARTICLE IV

The power to adopt, alter, amend or repeal bylaws shall be vested in the Board of Directors.

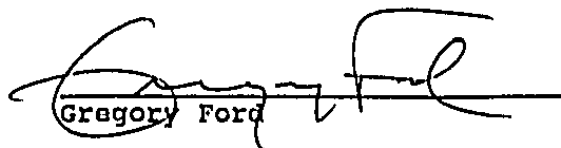

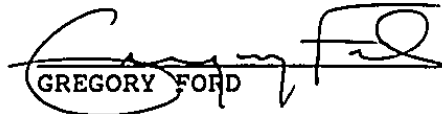
