ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this not for profit corporation is CARING HANDS HALFWAY HOUSE, INC. And the principle business address of this corporation is: 7202 Jonquil Drive, Orlando, Florida 32818

ARTICLE II - DURATION

This not for profit corporation shall have perpetual existence commencing on the date of the filing of the Articles with the Florida Department of State.

ARTICLE III - CORPORATE PURPOSES

The purpose for which CARING HANDS HALFWAY HOUSE, INC., is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of Section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

ARTICLE IV - CORPORATE POWERS

Notwithstanding any other provision of these Articles of Amendment, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

ARTICLE V - NO CAPITAL STOCK; DISSOLUTION

This corporation is organized on a non-stock basis. The corporation shall not issue stock, but membership of such corporation shall be evidenced by a certificate of membership which shall contain the statement, printed prominently upon the face of the certificate, that the corporation is a not for profit corporation. No dividends shall be paid, and no part of the income of the corporation shall be distributed to its members, directors, or officers. The corporation may pay compensation in reasonable amounts to its members, directors, and officers for services rendered and may confer benefits upon its members in conformity with its corporate purposes.

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or a corresponding section of any future federal tax code, or shall be distributed to the federal government, or to state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Common Pleas of the county in which the principle office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 7202 Jonquil Drive, Orlando, Florida 32818 and the name of the initial registered agent of this corporation at that address is Josh Leonard, Jr.

ARTICLE VII - QUALIFICATIONS OF MEMBERS

The qualifications of members and the manner of their admission shall be as regulated by the bylaws of this corporation.

ARTICLE VIII - INITIAL BOARD OF DIRECTORS

The directors of this corporation are to be elected or appointed in the manner specified in the bylaws of the corporation. This corporation shall have three directors constituting the initial Board of Directors. The number of directors may be either increased or decreased from time to time by the bylaws of this corporation. The name and address of the initial Board of Directors of this corporation are:

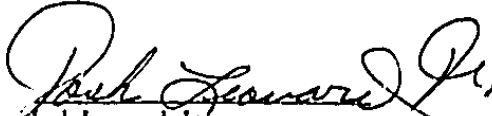
ARTICLE X - INDEMNIFICATION

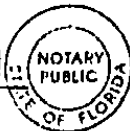
