The undersigned, acting as incorporator of a corporation pursuant to chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be: CENTRAL FLORIDA CHILD SEARCH AND RESOURCE CENTER, INC.

ARTICLE II
PRINCIPAL PLACE OF BUSINESS
AND MAILING ADDRESS

The current place of business and mailing address of this corporation shall be 1321 Lester Drive, Kissimmee, FL 34741. The corporation will lease office space ect. upon its incorporation.

ARTICLE III
PURPOSES

The specific purposes for which the corporation is organized are:

- A. To promote the education of the general public including but not limited to Children, Teachers, Day care workers, Law Enforcement agents and their agencies of the most current services and programs available on the subject of child abduction and its prevention.
- B. To promote a coordinated effort between Law Enforcement, News Media and other agencies to assist Families in the search and recovery of missing children.
- C. To offer families of missing children immediate and long term emotional support.
- D. To serve as a community RESOURCE CENTER providing information and training on the subject of missing children as well as distributing vital information and photographs of missing children to agencies and citizens that could be of assistance in locating missing children.
