**AMENDMENTS TO ARTICLES OF INCORPORATION**  
**Under Florida Statute 617.1006**

We, the undersigned, under the Not for Profit Corporation Act, and Florida Statute 617.1006, hereby amend the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation shall be:  
A TOUCH OF GOD MINISTRIES, INC.

The principal place of business shall be:  
2997 Tyrone Blvd. St. Petersburg, FL. 33710

A TOUCH OF GOD MINISTRIES, INC. may also have offices at such other places as the Directors/Overseers may from time to time designate, as per A TOUCH OF GOD MINISTRIES BYLAWS.

The mailing address shall be:  
P.O. Box 40968 St. Petersburg, FL. 33743

**ARTICLE II**

- A. This Corporation is organized and operated exclusively for the religious and charitable purposes within the meaning of Section 501 (c) (3), of the Internal Revenue Code of 1986, or the corresponding provision of any future United States Internal Revenue law in order to:

Minister the Word of God,  
Conduct regular religious worship services through various forms of ministries,  
Promote and encourage, through the ministries of this organization, cooperation with other organizations,  
Spread the Word of the Gospel by ministering to all through various media,  
Maintain the local church and ministry facilities,  
Provide training, licensing and ordaining of qualified individuals as leaders and ministers as determined by the By-Laws,  
Provide religious and educational instruction,  
Provide charitable assistance to those in need as detailed in the By-Laws.

#6. Officers, Director-Overseers, members, employees, volunteers and other representatives of A TOUCH OF GOD MINISTRIES and of the Corporation are not personally liable for any act, debt, liability or obligation of the Corporation.

### ARTICLE III

The Corporation shall have Officers and Director-Overseers as described in its Bylaws, who shall be appointed at such time, for such terms, by such qualifications, with such responsibilities and duties as provided for in its Bylaws.

### ARTICLE VI

Unless otherwise indicated by State or Federal law, governance of A TOUCH OF GOD MINISTRIES and the Corporation shall be subject to the Bylaws. The number of Director-Overseers shall be established by the Bylaws.

Authority, powers, limitations and indemnification of Officers, Director-Overseers, local and outside presbyters, members, employees, volunteers and other representatives of A TOUCH OF GOD MINISTRIES and the Corporation are to be followed as delineated in its Bylaws. Reassignment, removal or resignation of Officers or Director-Overseers shall be as provided for in the Corporate Bylaws.

### ARTICLE VII

The Officers of the Corporation shall be President, Vice President, Treasurer and Secretary, and such other Officers and assistants as may be provided for in the Bylaws.

### ARTICLE VIII

The Officers and Director-Overseers shall be subject to the terms and conditions of the Bylaws.

### ARTICLE IX

These Articles of Incorporation may be amended as per the Bylaws.
