## ARTICLE I:

The name of the corporation shall be "The Frank & Sarah Salizzoni Charitable Foundation, Inc."

## ARTICLE II: Principal place of business and mailing address

The principal place of business and mailing address of this corporation shall be:

## ARTICLE III:
