ARTICLES OF INCORPORATION
OF
CHABAD OF DEERFIELD BEACH, INC.
A NONPROFIT CORPORATION

WE, THE UNDERSIGNED INCORPORATORS, by these Articles of Incorporation hereby form a Not-For-Profit Corporation pursuant to the provisions of Chapter 617 of the Florida Statutes.

Article I

The name of this not-for-profit corporation shall be:

Chabad of Deerfield Beach, Inc.

The principal place of operations of this corporation and the mailing address of the corporation shall be 1068-104 South Military Trail, Deerfield Beach, FL 33442.

Article II

This corporation is organized for the exclusively for charitable, religious, educational and, literary purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any other provision of these articles, this corporation will not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United State Internal Revenue Law.

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which are themselves exempt as organizations described in sections 501(c)(3) and 170(c)(2) of the Internal revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code, or to the Federal, State, or local government for exclusive public purpose.

Article III

The manner in which the directors are to be elected or appointed is as stated in the by-laws.

Article IV
