WE, THE UNDERSIGNED, hereby certify that we have associated ourselves together for the purpose of establishing a non-profit corporation under and in accordance with the provision of Chapter 617 Florida Statutes, providing for the information, rights and privileges and immunities of the corporation for non-profit and in pursuance of the terms of said Statutes, we hereby declare and certify as follows:

#### ARTICLE I. NAME

The name of this corporation shall be: Islamic Center of New Port Richey Area, Inc. The mailing address of the corporation shall be: 3739 Erin Brook Drive, New Port Richey, FL 34655.

#### **ARTICLE II. DURATION**

This corporation shall exist in perpetuity.

#### ARTICLE III. PURPOSE/OBJECTIVE

This Corporation is formed for lawful non-profit purposes and objectives. No stock or securities will be issued. All corporate assets will be dedicated to exempt purposes; although the corporation will be authorized to pay reasonable compensation for services rendered, and to enter into business transaction in furtherance of its exempt purpose, the corporation will not pay dividends, and its assets will not inure to the private profit of any person. If and when the corporation is dissolved, its assets will be distributed for exempt purposes, or will devolve to a government agency for a public purpose. None of the assets will be distributed to private individuals.

(a) The purpose/objective shall be, including, but not limited to:

- 1.) To unite all Muslims of both sexes regardless of other affiliations in the service of Islam;
- 2.) To assist other Muslim organizations in order to strengthen Islamic movements in a peaceful manner;
- 3.) To extend educational, economic, social, cultural, and humanistic assistance to the community at large.
- 4.) To acquaint Muslims through literature and other education means with our duties and obligations to each other and to mankind, in general, so as to promote active participation of the membership in all the activities of the Islamic Center of New Port Richey Area, Inc.
- (b) To own, buy, purchase, exchange, hire, lease, mortgage, or otherwise acquire real estate and property, either improved, or any interest or right therein, and to own, hold control, maintain, manage and develop the same in any state of the United States.
- (c) The corporation shall have the lawful right to transact any and all other lawful business.

#### ARTICLE IV. MEMBERSHIP

This is a Membership corporation which is authorized to issue Membership Certificates to members, and shall maintain a membership book in accordance with Florida Statute 617.050(4) and shall be subject to the definitions and conditions set forth in the by-laws. There shall be two (2) classes of membership, (1)Registered Member, and (2)Registered Voting Member.

#### ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this corporation is 3739 Erin Brook Drive, New Port Richey, FL 34654, and the name of the registered agent of this corporation is AYUB A. MODI.

#### ARTICLE VI. INITIAL BOARD OF DIRECTORS

This corporation shall have seven (7) directors initially. The number of directors may be either increased or diminished from time to time by amendment to, or in the manner provided in the by-laws but shall never be less than three (3). Directors shall be elected or appointed in the manner and for the terms provided in the by-laws.

#### ARTICLE IX. POWERS OF THE CORPORATION

The powers of the corporation will include all powers granted by the state to non-profit corporations of the same type. In addition, the corporation's powers will include the following, to the extent not prohibited by state or federal law:

- (a) To solicit, collect, receive, hold, invest, distribute, and disburse funds in the forms of donations, gifts, bequests, and subscriptions;
- (b) To accept gifts from individuals, corporations, and foundations in furtherance of the corporation's non-profit purpose;
- (c) To borrow funds with or without security, on terms at least as favorable as those offered on the open market, to carry out the corporation's non-profit purpose, as authorized by at least three of the corporation's directors and approved by the state's regulators of charitable organizations:

(d) The power to engage in fund-raising events, for example, benefits and sales of donated merchandise, provided that these events are infrequent and irregular, not tantamount to maintenance of a profit-making business, and provided that the income derived from these events, net of reasonable expenses, will be entirely devoted to the organization's non-profit purpose.

#### **ARTICLE X. BY-LAWS**

The power to adopt, alter, amend or repeal by-laws shall be vested in the Board of Directors.

#### **ARTICLE XI. MEETINGS**

The corporation's Board of Directors will meet at least quarterly, with additional meetings as called by three or more directors. The corporation will hold a general membership meeting at least annually, and meetings can be called by demand of three Directors, or at least 25% of the members acting by notifying the Board of Directors, which will then notify the membership of the date, time, place, and reason for the special meeting.

#### **ARTICLE XII. AMENDMENTS**

Power to amend the organization's Articles of Incorporation and By-Laws will rest with the Board of Directors.

#### ARTICLE XIII. DISSOLUTION

in the event this corporation shall be dissolved or liquidated, said dissolution/liquidation shall be in accordance with Florida Statutes 617.1405 and 617.4106.
